This notice is published in accordance with Article 13 of the Contract Notice for the subject project.

The **mandatory site visit** will be held on **01-02 October 2014 (both inclusive)** at the site [from Samsun to Kalin (Sivas)]. All participants shall deliver an **authorization letter** that shows clearly the identity of participant representing the potential tenderer. The authorization will be given with an official letter with letterhead for each person, duly stamped and signed by the persons that have the authority to represent the company. In case the latter is going to attend the site visit, the official letter will be drawn up for himself/herself. No notarial attestation is needed. The authorization letters shall be supported by the identity card, passport or driving licence of the respective participant(s).

The Contracting Authority will distribute a **participation certificate** to each potential tenderer. **These certificates shall be included in the tenders.**

The participants are required to be ready **at 8:45 a.m. in the Samsun Railway Station. At most two (2) representatives are allowed to participate to the site on behalf of one (1) company.**

The information/clarification meeting will be held **at 19:00 p.m. on Thursday, 2nd of October 2014** at the Sivas Railway Station **Directorship.**
